



## *Oldest Furnace in Hampton Roads Entry Rules*

1. No entry fee or purchase is required.
2. The odds of winning are based on the number of entries received.
3. Entries must be received between September 1, 2020 and October 31, 2020. One entry per person. One entry per home.
4. The furnace must be operating and providing heat to the home.
5. Entrants must be 21 years or older, must own the home entered in the contest, must be fully empowered to make purchase and home improvement decisions regarding their residence, and reside within our service area.
6. Representatives from Miller's Heating and Air Conditioning must be allowed access to the furnace to examine the installation and record manufacturer nameplate information.
7. The contest is open to owner-occupied, single-family homes.
8. Entry details must include homeowner's name, address, email address, phone number, and photographic evidence of their furnace.
9. The winner will be the oldest furnace submitted according to objective information (e.g., the furnace nameplate), installation or sale paperwork provided by the homeowner, or the best judgment of panel of furnace experts based upon creativity and the age of the furnace. All decisions are final.
10. The winner will be selected on November 12, 2020 and informed by telephone or email prior to media announcements.
11. The winner will be posted online at [MillersHomeComfort.com](http://MillersHomeComfort.com) by November 13, 2020.
12. The winning entry will agree to Miller's Heating and Air Conditioning using the homeowner's name, submitted story, image and images of the old and new furnaces in announcements and promotions.
13. The winning entry will receive a Ruud High-Efficiency system valued at up to \$8,700.00 plus maintenance plan for first year. Prize is non-transferable and may not be redeemed for cash.
14. The winner will provide Miller's Heating and Air Conditioning with 12 months of heating bill information prior to the replacement, 12 months of heating bill information following the installation, and release Miller's Heating and Air Conditioning to share this information with the public.
